- Understand the relationship between ethical content and ethical process
- Review codes and laws relevant to their specific offense
- Communicate the harm done from ethical/legal violations
- Identify and define violation potentials for ethical issues utilizing the Ethics Formula
- Create an Ethics Protection Plan to maintain and safeguard professional ethics
- Learn to utilize peer group discussions for ethical dilemma resolution

- · Telephonic Review: 1 hour
- Telephonic Seminar (MAS): 4 hours (four 1-hour sessions)
- Readings (Ethics Formula): 45 minutes
- Ethics Formula assignment: 45 minutes
- Readings (Understanding Vulnerabilities, Seeking Forgiveness): 1 hour
- Ethics Protection Plan assignment: 30 minutes
- Telephonic Review: 1 hour
